**EXPLANATORY GUIDELINES FOR AN APPLICATION FOR AN ARMAMENTS DEVELOPMENT,
MANUFACTURING AND / OR SERVICES PERMIT**

1. The purpose of an Armaments Development, Manufacturing and / or Services Permit is to identify and register companies involved in conventional arms trade and to regulate their activities.
2. Development in relation to armaments includes development, research, design and conceptual studies, whereas manufacturing includes the assembly, testing and qualification / certification thereof.
3. Applications are to be submitted in English in the prescribed Form DMP 6.1 and shall be completed in either typescript or in capitals in ink.
4. The Directorate Conventional Arms Control shall not accept any form other than Form DMP 6.1.
5. Applications are to be forwarded to the Directorate Conventional Arms Control by a secure means. Facsimile applications will not be accepted.
6. The Minister of Defence publishes armaments, related products and dual-use goods in the Government Gazette.
7. The National Conventional Arms Control Committee through the Minister of Defence may at any time cancel or suspend an Armaments Development, Manufacturing and / or Services Permit.
8. The Armaments Development, Manufacturing and / or Services Permit is not transferable.
9. A comprehensive list of the physical address of all the company's premises is to be provided.
