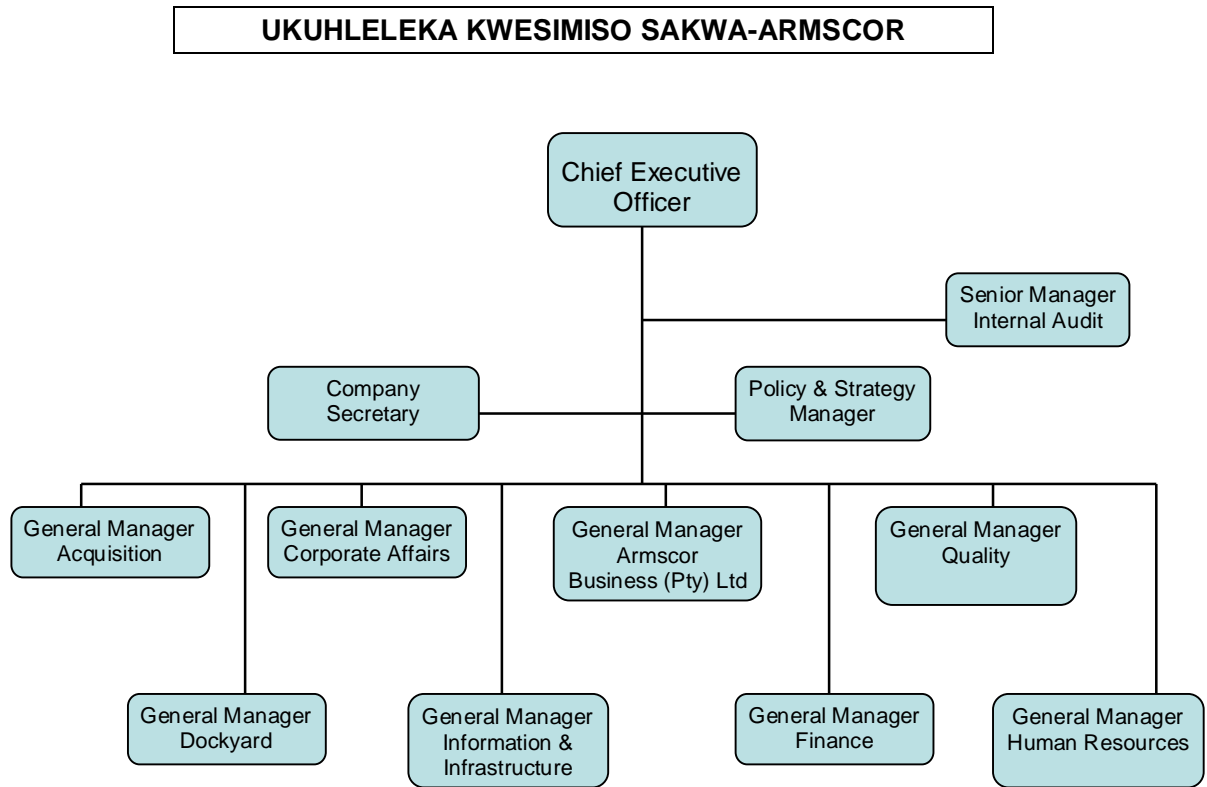
5.3 IMISEBENZI

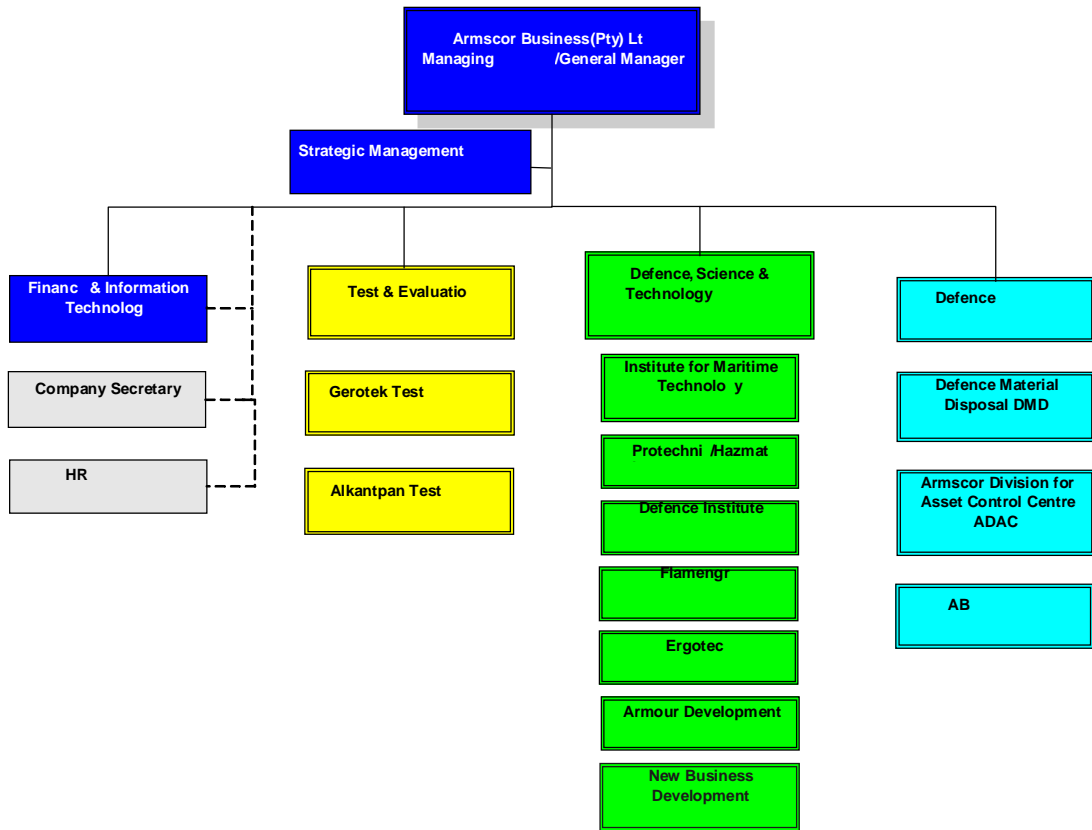
